

## **ICD-10, Implementation, Training and Certification**

October 1, 2014 will be here before we know it – training staff and organizing the implementation effort has left a number of practices asking where I begin. October 2014 is the date that the Centers for Medicare and Medicaid Services (CMS) has set for healthcare entities to complete their transition from ICD-9-CM to ICD-10 code sets. These code sets, known as the International Classification of Diseases, 10th Edition diagnosis and procedure codes, or ICD-10, will include codes for new procedures and diagnoses that improve the quality of information available for quality improvement and payment purposes. Developed by the World Health Organization in 1993, ICD-10 is already in use nearly worldwide. ICD-10-CM is a far superior system to ICD-9-CM and the will codes increase from around 14,000 to about 68,000.

ICD-10 implementation will accommodate a number of new procedures and diagnoses unaccounted for in the ICD-9 code set and allow for greater specificity of diagnosis-related groups and preventive services. This transition will lead to improved accuracy in reimbursement for medical services, fraud detection, and historical claims and diagnoses analysis for the health care system. ICD-10 will have far-reaching positive effects on quality issues, including the use of specific reasons for patient non-compliance and detailed procedure information by degree of difficulty.

### **ICD-10-CM/PCS consists of two parts:**

- ICD-10-CM - The diagnosis classification system developed by the Centers for Disease Control and Prevention for use in all U.S. health care treatment settings.
- ICD-10-PCS - The procedure classification system developed by the Centers for Medicare & Medicaid Services (CMS) for use in the U.S. currently designated to replace Volume 3 of ICD for inpatient hospital settings ONLY directed towards allocation of hospital services. CPT® remains the procedure coding standard for providers regardless of whether the provider services are provided in the inpatient or outpatient setting.

As with any project of this magnitude, the scheduled implementation date has experienced some delays the conversion process, however, continues to move forward. What is clear is that the actual work to successfully transition to the new system should already be well underway before the full implementation date.

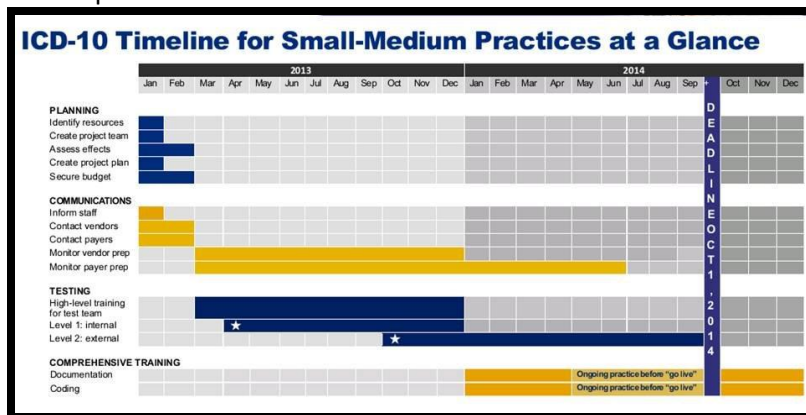
## Implementation Steps and Guidelines

While the final date of implementation was delayed by one year, it is clear is that preparations should not stop! Everyone in the office needs to familiarize themselves with the new coding system now.

Overall, the 6 Stages of ICD-10 implementation include:

- Planning
- Communication and Awareness
- Assessment
- Operational Implementation
- Testing
- Transition

The Centers for Medicare and Medicaid Services (CMS) has published numerous beneficial resources on their website to help health care professionals acquaint themselves with ICD-10, including the timeline chart below for ICD-10 implementation.
